

### CHAIRMAN'S STATEMENT



Notwithstanding, the logistics industry is expected to continue on a growth trajectory. Aimed at reinforcing Singapore's position as a global logistics hub, the government launched the Logistics Industry Transformation Map (ITM) that will support enterprise-level efforts to transform and grow through productivity and innovation. It aims to nurture a strong Singaporean core

through talent development, which will in turn help our companies, in particular, the small and medium-sized enterprises, to scale up and internationalise. The logistics industry transformation is expected to achieve a value-add of S\$8.3 billion to the sector, and introduce 2,000 jobs for professionals, managers, executives and technicians (PMETs) over a five-year period.

As part of the ITM effort, the Association together with the Economic Development Board, SPRING Singapore and Workforce Singapore published the Logistics Industry Career Guide Book. With the theme "Let the World be Your Limit", the guide features the careers of 9 logistics professionals who have risen through the ranks and developed new skills sets in areas like

Logistics Information Systems, Vertical Specialisation, Logistics Solutioning and Programme Management to take on new opportunities in the industry. It intends to attract new entrants into the industry with comprehensive view on career opportunities and progression in the logistics industry.

During the year, the Association was awarded the Local Enterprise & Association Development Programme (LEAD) Plus by SPRING Singapore. The programme aims to enhance the capabilities of trade associations that are playing a significant role in industry transformation. Through LEAD Plus, the Association aspires to increase membership by 20% and encourage more members' participation on useful initiatives on internationalization. productivity & innovation, and skills development. This award is timely as the Association wrapped up its LEAD 2 journey to a successful completion in 2016 through the 9 initiatives under 3 strategic thrusts: Productivity, Manpower Attraction and Internationalization. One of these projects, Supply Chain Challenge, 5th in the series, was again successfully rolled out. Organized jointly with SIM University, it is an event that reaches out to the young, inducting students from the five polytechnics and ITE to the industry through six mentorcompanies.

To adopt the best practices of the overseas Trade Associations and Chambers (TACs), both Mr Kay Kong Swan — 1st Deputy Chairman and I joined the TAC Mission to USA - Salt Lake City and San Francisco in August 2016, organised by SPRING Singapore. Together with other TACs, we gained valuable insights into overseas TACs' governance, strategies and services. Through sharing sessions on the best practices, we also enhanced our understanding on association management and governance from the American Society of Association Executives Annual Meeting and Exposition at Salt Lake City. We hope our new knowledge will supplement the implementation of LEAD Plus to enhance the capability of the Management and Secretariat team.

As for training and upskilling of our workforce, The Logistics Academy - our training arm is constantly reviewing and developing new training programmes to equip our workers and create the avenue for skills development and lifelong learning. We have all benefited, much thanks to our proactive government agencies that spare no effort in supporting us in this effort.

A strategic review in the early part of the year pointed to a need for stakeholders in the sector to collaborate, leverage on technology to drive innovation, connectivity and value creation. The e-Logistics / Technology Committee was thus renamed as Innovation & Collaborative Technology Committee with the term of reference, "Creating synergy with industry partners and raising awareness on smart innovation and digital technology so as to benefit the members." Several ideas have been incubated, which include piloting the use of Automated Guided Vehicles in a third-party logistics setting

as well as a regional portal to drive cross border trade. Eventually, Singapore logistics service providers can leverage on the global connectivity platform to gain access to the global markets, seek new growth opportunities and create value for the logistics and supply chain industry. Works are in progress and we hope to bring these projects to fruition by next year. The year also saw the Association championed and coordinated the successful inauguration of the WSH Innovation Awards 2016 for Logistics and Transport Sector. It is a good recognition of work teams in the logistics and transport sector which have initiated innovative practices or solutions that improve safety and health in the workplace.

Each step forward made by the Association is a concerted effort of the entire membership together with stakeholders, including the government agencies, specifically SPRING Singapore, IE Singapore and Workforce Singapore, academia and industry partners. I would like to take this opportunity to convey my sincere thanks to the Council and the Secretariat for their commitment, trust and contributions to the Association. Key indicators are showing that the tide is gradually turning for 2017, with the long-awaited domestic manufacturing recovery. The future in logistics augurs well. Let us all work together to make an impact and bring the logistics industry to a new level.

# Outreach

By year end 2016, membership of the Association reached a new high of 560, with 40 new admissions during the year and 2.6% rise from the year before. The upward trend in membership since its foundation in 1973 bodes well of its representation of the logistics industry.

With sanction of general members at the SLA 41st Annual General Meeting held on 21 May 2015, the revised Constitution was approved by the Registry of Societies on 30 October 2015. The membership categories were expanded with the introduction of a new category — Qualifying Membership. The objective is to create a more inclusive community to encourage a culture of diversity within the logistics fraternity. On 25 January 2016, the Council approved the conversion of the following 21 companies from Associate Members to Qualifying Members. They all met the criteria of Qualifying Members under the revised Constitution as set out in Article 5.3.



As the unifying voice of the industry, the Association represents the needs and interests of members by actively engaging policymakers and relevant government agencies on strategic initiatives and key issues. Through company visits, the Secretariat team continued to embrace new members into the community and induct them with good understanding of the Association's activities and its training initiatives through The Logistics Academy Pte Ltd.





# 42nd Annual General Meeting

Close to 100 member-representatives and observers attended the SLA 42nd Annual General Meeting (AGM) held on 27 May 2016 at Novotel Singapore Clarke Quay. In his welcome address, Mr Stanley Lim – Chairman denoted the year before as a significant year for Singapore as the nation celebrated its 50th year. Although various challenges stood in the way due to sluggish global economic conditions, companies were putting in efforts to

critically and creatively look at business transformation, and generate problemsolving ideas. One area identified is trucking and warehousing operations, where the Association would explore with solution providers to work on a productivity-driven growth model.

Another area was internationalisation where two business missions were organised in 2015 to Indonesia –

Surabaya & Jakarta, and China – Beijing, Yinchuan & Xi'an.

With the advent of the ASEAN Economic Community and the One Belt One Road initiative, these missions were timely to allow companies to explore expansion of their businesses in the global market through collaborations and new alliances. There were also continuous efforts to promote logistics









as a career amongst tertiary students as well as the workforce. The fourth series of the Supply Chain Challenge (SCC) concluded on a high note on 27 July 2015 and provided an effective platform to outreach students. Along the same thread, the Association had been invited to participate in the National Logistics Sector Manpower Study Advisory Panel and SkillsFuture Sectoral Tripartite Committee for Logistics Sector.

The Logistics Academy (TLA) too had put in place a whole suite of training programmes, including several new courses, all geared towards a holistic approach to experiential learning for the logistics community.

Several of these are listed in the SkillsFuture directory. A new website, TLA.EDU.SG was also launched to create a community of network amongst lecturers and participants.

General members present elected the SLA

Council for the term 2016/2017 and approved the minutes of the 41st AGM held on 21 May 2015, report of the Council and financial statements of the association for the year ended 31 December 2015.

PKF-CAP LLP was reappointed as Auditor until the next AGM.



# **SLA CEO Night**

Graced by Mr Poon Hong Yuen — Chief Executive of SPRING Singapore, over 120 representatives and CEOs from member-companies as well as guests were present at the CEO Night held on 04 November 2016 at Orchard Parade Hotel. Amongst them were key representatives from SPRING Singapore, IE Singapore and Workforce Singapore, as well as Container Depot Association (Singapore), SAAA@Singapore and Singapore Transport Association.

In his welcome address, Mr Stanley Lim – Chairman highlighted that several industry work initiatives had been successfully carried out under 2 Local Enterprise & Association Development Programmes (LEAD) over a period of 8 years. help even more logistics companies take advantage of the opportunities available. The night thus commemorated the close collaboration between the industry and government agencies. The works and activities of the Association would not be made possible without the strong support of relevant government agencies.

Mr Poon also presented mementoes to Council Members in appreciation of their unreserved and invaluable contributions during the last 2014/2015 term.

# Chongqing Xiyong Comprehensive Bonded Zone



# Japan International Freight Forwarders Association

Besides exchanging information on the activities of both associations as well as the economic situations and education systems of both countries, the discussions centered on the steps taken by both countries in preparation for the implementation of the Safety of Life at Sea (SOLAS) regulation that would take effect from 01 July 2016.

# Thai Trade Centre

A total of 22 delegates from the Thai Logistics Businesses called on SLA on 16 May 2016. The delegates were on a 4-day mission to Singapore from 16 to 19 May 2016 to establish ties with Singapore logistics companies and to study the systems adopted by Singapore logistics operators that contributed in making Singapore a logistics hub of Asia. The itinerary included visits to the port and several member-companies. They were accompanied by officials from the Thai Trade Centre who also gave a brief on TILOG – LOGISTIX, an event for businesses to discover the right logistics services and solutions. Co-organized by the Department of International Trade Promotion and Reed Tradex, it would be held in Bangkok from 21 to 23 September 2016. Presided by Mr Stanley Lim – Chairman, 18 representatives from member-companies joined the roundtable, exchanged business cards and proceeded with one-to-one introductory meetings.







# Thammasat University of Thailand

Mr Thomas Sim – Second Deputy Chairman, Mr Fabian Wang – Member of Training & Development Committee and the Secretariat hosted a total of 36 delegates from the Thammasat University of Thailand on 25 August 2016. The trip to Singapore was part of the training course on Management Skills Development conducted by the University for the Port senior executives. The Association and the delegation had a lively discussion on the trends and development in Singapore and the region.

A full set of the SLA publications — The Practitioner's Definitive Guide was presented to the mission leader.

# Yamato Holdings and Deloitte Japan

Representatives from Yamato

overview of Yamato Holdings and its

The Indonesian Logistics & Forwarders Association led a delegation of some 27 freight forwarders from Central Java to Singapore and Malaysia from 19 to 21 September 2016.

#### Local Enterprise and Association Development Programme (LEAD)

In a panel discussion held at the LEAD Partners Dinner on 10 May 2016 at ParkRoyal on Beach Road Hotel, Mr S Iswaran - Minister (Industry) from Ministry of Trade & Industry announced that International Enterprise (IE) Singapore and SPRING Singapore would set aside a grant budget of about S\$90 million over the next five years to develop industries through LEAD. This is a 20% increase from the \$75 million

set aside for the programme in 2011. The fund supports trade associations and chambers like SLA to undertake projects that will drive industry transformation for evolving sectorial needs.

Since 2007, SLA benefitted from 2 tranches of LEAD grant, rolling out initiatives covering industry branding, productivity improvement, skills development and talent attraction as well as internationalization. They not only helped our members improve capabilities and grow their businesses, the support also helped foster collaboration among various stakeholders.

Several SLA Council Members and the Executive Director joined business leaders and members of other trade associations and chambers at the dinner.

# LEAD 2: Supply Chain Challenge

SLA's 4-year LEAD 2 ended successfully in 2016.

The Supply Chain Challenge (SCC) themed "Young Minds ... Future Ready Logistics Professionals" was kick started on 10 May 2016 at SIM University (UniSIM) for the fifth season.

The yearly national case competition was jointly organized by SLA and UniSIM with support from International Enterprise Singapore and SPRING Singapore. The event was graced by Ms Low Yen Ling — Parliamentary Secretary, Ministry of Education & Ministry of Trade and Industry and Mayor, South West CDC.

One of the highlights at the SCC 2016 Launch was the acknowledgement of logistics companies which participated in the pilot run of the SkillsFuture Enhanced Internship Programme for Logistics, in alignment with the nationwide SkillsFuture movement.

A total of 63 teams consisting of 232 students from the 5 local polytechnics







and ITE College East were registered for the SCC.

Unlike previous years where the competitors were presented with the challenge of analyzing and proposing solutions to one supply chain management case study, the competitors visited 8 mentor-companies and were introduced to their respective business cases.

Cash Prize : \$1,000



### INTERNATIONAL & INDUSTRY RELATIONS COMMITTEE

#### **LEAD Plus**

During Singapore Budget on 24 March 2016, Mr Heng Swee Keat – Minister for Finance announced a S\$4.5 billion package targeted at providing support to firms and industries while driving innovation. Under this programme, 23 sectors will have blueprints drawn out for them and the Industry Transformation Map (ITM) for Logistics was launched on 16 November 2016 by Mr S Iswaran - Minister for Trade and Industry (Industry) at the Ground Breaking of the JTC Logistics Hub @ Gul event. Parallel to the ITM, the government will work with trade associations and chambers and the unions to address pressing issues in the medium to long term.

SLA has been identified as the lead trade association to play a critical role. SPRING Singapore introduced and awarded SLA LEAD-Plus programme to help beef up its capabilities in guiding sectoral transformation. An Executive Committee comprising Mr Stanley Lim — Chairman, Mr Kay Kong Swan — 1st Deputy Chairman, Mr Thomas Sim — 2nd Deputy Chairman and Mr Gerry Tan — Honorary Secretary was formed to oversee SLA LEAD-Plus which will cover leadership, management, processes and services for higher value.



### SkillsFuture Sectoral Tripartite Committee for the Logistics Sector

The Association is represented by Mr Stanley Lim - Chairman at the SkillsFuture Sectoral Tripartite Committee (STC) for the Logistics Sector. The committee will oversee the development and implementation of the of the Logistics Sectoral Manpower Plan which will outline a forward-looking approach to developing skills and career progression pathways, as well as plans to attract, develop and retain a Singaporean pool of talent. 2 meetings of the SkillsFuture STC for the Logistics Sector

were held during the year on 23 March and 11 August 2016 where Mr Gerry Tan – Honorary Secretary / Chairman of Air Cargo Committee and Ms Ng Soo Hwa – Executive Director attended.

An initiative of the committee, SLA was tasked to take the lead in reprising the industry branding movement and to bolster the appeal of the logistics industry. This included the production of the Logistics Industry Career Guide that was launched on 16 November 2016

in conjunction with the ITM launch. The guidebook was showcased and introduced by Mr Thomas Sim — 2nd Deputy Chairman / Chairman — Training & Development. It featured 9 logistics professionals, each with skills sets in areas like Warehouse Management & Operations, Transportation Management & Operations, Freight Forwarding & Operations, Sales and Customer Service, Logistics Solutioning & Programme Management, Logistics Process Improvement & Information System.



#### Singapore Budget 2016

Following the announcement of Singapore Budget 2016, Mr Kay Kong Swan — 1st Deputy Chairman represented SLA at a roundtable discussion with the Minister for Finance, Mr Heng Swee Keat on 10 March 2016 together with other industry groups.

Singapore Budget 2016 aimed to be targeted at growth sectors and how the different targeted industries could be developed.

The Singapore Business Federation (SBF) with the support of the Ministry of Finance also organized a Singapore Budget 2016 briefing on 01 April 2016 for several trade associations and chambers. SLA was represented by Mr Stanley Lim — Chairman, Mr Thomas Sim — 2nd Deputy Chairman, Mr Gerry Tan — Honorary Secretary / Chairman of Air Cargo Committee and Ms Gina Toh — Deputy Honorary Treasurer.

### 2016 Taiwan-Singapore Logistics Exchange and Cooperation Forum



The Association convened a meeting with NTUC U SME on 12 July 2016 to gain insights into their programmes, events & training programmes.

# Singapore Environmental Achievement Awards 2016



The Association supported the Singapore Environmental Achievement Awards (SEAA) 2016 that was held on 20 July 2016. Organised by the Singapore Environment Council, the event was graced by Mr Masagos Zulkifli - Minister for the Environment and Water Resources. The awards aim to increase the level of environmental performance and awareness amongst organisations operating in Singapore. It also encouraged industries to adopt a more proactive approach towards managing the environment.

### Tripartite Workgroup for Age Management and Job Re-design

The tripartite workgroup for age management and job re-design headed by Mr Heng Chee How – Deputy Secretary General of NTUC is tasked to:

- study challenges faced by sectors with high concentration of older workers
- develop a diagnostic tool to help companies identify areas of work which could be made more age-friendly
- identity training for line managers in job redesign
- build up an eco-system for job-redesign and age management expertise

The workgroup together with MOM and WDA have identified four target industry sectors namely retail, hotel, F & B and logistics / supply chain. Representatives from the workgroup, MOM and WDA convened a meeting with SLA on 02 August 2016 to share on the job redesign toolkit for the logistic industry, resources available and explore how it could be rolled out to the industry.



# Trade Associations and Chambers Mission to USA

Mr Stanley Lim — Chairman and Mr Kay Kong Swan — 1st Deputy Chairman, together with several representatives from other trade associations and chambers (TACs) in Singapore participated at the TAC Mission to USA - Salt Lake City and San Francisco from 13 to 18 August 2016.

Organized by SPRING and IE Singapore LEAD Programme Offices, the aim of the mission was for TACs to understand the best practices of the overseas TACs such as:

- TAC governance and succession
- Process of identifying and implementing strategies and services that advance their respective industries and membership
- Ensuring relevance to attract future members

During the trip, the delegates attended the American Society of Association Executives (ASAE) Annual Meeting and Exposition at Salt Lake City organised by ASAE.



The annual conference was packed with sharing sessions on the best practices with regard to association management and governance.

The presentations from UNESCAP Regional Conference mapped out the latest work developments:

Latest updates with relevance to freight forwarders, multimodal transport operators and logistics service providers by Ms Virginia Tanase — Chief, Transport and Facilitation Section, Transport Division, ESCAP.

- Cargo security and transit challenges by Mr Izhar ul-Haq Qamar – Chairman, Pakistan International Freight Forwarders Association.
- Co-modality in Providing Logistics Services by Mr Roy van den Berg – Consultant, The Netherlands.

The FIATA RAP Field Meeting covered a wide ranging agenda which include:

- Matters relating to Airfreight, Mutimodal Transport, Customs Affairs, Safety and Security, Vocational Training as well as Legal Matters and International Affairs in the region.
- Indonesia Special Section with presentation by Coordinating Ministry of Economic Affair and presentation by Indonesia Sea Port Operator – PELINDO IV – on Indonesia Maritime Highway: alternative for logistics in the archipelago.

### FIATA World Congress 2016

Mr Stanley Lim – Chairman and Mr Thomas Sim – 2nd Deputy Chairman represented the Association at the FIATA World Congress (FWC) held in Dublin, Ireland from 03 to 08 October 2016.

The Congress coincided with FIATA's 90th Birthday. Founded in 1926, FIATA now represents an industry covering over 40,000 forwarding and logistics firms in 160 countries.

Hosted by the Irish International Freight Association, the congress presented a new format and welcomed an array of high level speakers to discuss key topics of the industry, with a strong accent on innovation.

One of the highlights of the congress included the signing of the IATA FIATA Air Cargo Program (IFACP) Cooperation Agreement during FIATA's Airfreight Institute's 95th meeting. Mr Zhao Huxiang — FIATA's President and Mr Tony Tyler, IATA's Director General signed the agreement to implement IFACP to replace the existing IATA Cargo Agency Program.

Other agreements with strong government support were prominently featured and attracted global and regional attention.

One of which was the signing of a Memorandum of Understanding (MOU) among DNeXPORT Sdn Bhd of Malaysia, GeTS Asia Pte Ltd (SLA member) and Tiffa Edi Services Co Ltd of Thailand on 06 October 2016 to strengthen cooperation and partnership in the field of Trade Facilitation.

The MOU signing was witnessed by Minister of Transport Malaysia Yang Berhormat Dato Sri Liow Tiong Lai.

The event also featured several networking opportunities for delegates and a great number of technology vendors in the exhibition hall.

TT Club and FIATA celebrated the achievements of young freight forwarders around the globe at the annual FWC. The 2016 Young International Freight Forwarder of the Year Award was presented to Ms Shanon Gould from Australia, representing the Asia-Pacific region.







# The Association of Banks in Singapore

The Association continued to engage the banking community on possible strategic partnership and collaboration.

A meeting was convened on 21 April 2016 with The Association of Banks in Singapore (ABS) to delve on the possibility of putting in place a standard road transport document in place of delivery orders.

The current practice is that sellers and buyers mostly outsourced goods

delivery to transport to service providers and these companies issue their own documents and electronic proof of delivery. ABS would further the deliberation and seek the views of traders.

In another development, Ms
Charmaine Fu — TLA's Lecturer was
nominated to speak at the Annual
Survey of Letter of Credit Law & Practice,
organised by the Institute of International
Banking Law & Practice (IIBLP) from 11
to 12 July 2016.

# MARITIME CARGO COMMITTEE

# Safety of Life at Sea

The Association together with several logistics representatives and shipping companies attended a meeting on 31 March 2016 convened by the Maritime and Port Authority of Singapore (MPA) to delve on the amendment to the International Convention for the Safety of Life at Sea (SOLAS) before it took effect from 01 July 2016. It was affirmed that operations at PSA would remain at status quo. All containers would be weighed and the Verified Gross Mass (VGM) recognized for stowage planning and assessment by the shipper.

Member-companies were invited to a seminar on Container Weight Regulations, Chapter VI Regulation 2 organised by the Singapore Shipping Association on 10 June 2016. The workflow process for local export containers handled at PSA terminals were explained to the participants in detail.

Following the implementation on 01 July 2016, MPA conducted another meeting on 19 August 2016 for feedback and reviewed the number of containers that were shut-out due to unconfirmed VGM. Stakeholders had been urged to comply with the requirements.

With effect from 27 October 2016, PSA provided a new feature in the Electronic Shipping Note transaction in Portnet to opt for the VGM Monitoring Service. When this option is selected, export container weight exceeding the 5% VGM discrepancy would automatically be updated to PSA derived weight when the container arrived in the port. At \$1 per container, the monitoring service would prevent containers from being shut out or requiring last minute weight amendments which would incur additional charges.

# Golden Chariot International Transport Award

Mr Stanley Lim — Chairman and past FIATA President was bestowed the award of "Achievement for Strengthening International Relationships in the Transport Sector" at the Golden Chariot Award Ceremony held at the end of the opening session of the 2nd meeting of the Enlarged FIATA/UIC Railway Contact Group on 12 May 2016 in Shenzhen, China. Amongst the list of winners, there were 2 from Singapore, including Singapore Airlines that won the Leader of Air Transport in 2011.







# Sea Checkpoints Security Coordinating Committee

The Association, as represented by Mr John Iversen – Council Member / Chairman of Maritime Cargo Committee participated in the meetings of the Sea Checkpoints Security Coordinating Committee, a joint collaboration between Immigration & Checkpoints Authority of Singapore and Ministry of Home Affairs. With the mandate to oversee security issues at the land-based sea checkpoints, the 1st, 2nd and 3rd committee meetings were held respectively on 20 January, 23 May and 18 November 2016.

### TILOG – LOGISTIX 2016

The Department of International Trade Promotion (DITP), Ministry of Commerce and Reed Tradex jointly organised TILOG – LOGISTIX 2016 from 21 to 23 September 2016 in Bangkok,

Thailand. Attended by 10,263 attendees, it was an exhibition on LSPs, technologies and solutions for ASEAN + 6. The event also featured a Singapore Pavilion, showcasing the products and services of

Singapore companies. Mr Stanley Lim – SLA Chairman was one of the speakers at the panel discussion of the Logistics 4.0 Symposium 2016.





# Singapore Customs

Member-companies were invited to a one-day export control seminar on 09 September 2016 organised by the US Bureau of Industry and Security, US Export Control and Related Border Security, Japan Ministry of Economy, Trade & Industry and Singapore Customs. The seminar provided unique opportunities to delve on the recent developments on Strategic Trade Management.



# Air Cargo Security Work Group

Member-companies were invited by the Air Cargo Security Work Group to a briefing on Air Cargo Security Review on 12 January 2016. The session presented the implementation plans of the approved



recommendations by the National Civil Aviation Security Committee, to extend the Regulated Air Cargo Agent Regime (RCAR) to all-cargo aircraft and regulating Known Consignors.

Subsequently, a focused group discussion was held on 29 July 2016 where the attendees provided their inputs on the operational matters, cost implications and preference of the proposed increased screening implementation timeline. Member-companies were invited to a series of workshops organised between May to July 2016 to familiarize Consignors with the Known Consignor Security Programme requirements once it is implemented.

# Ministry of Transport

The Ministry of Transport organized an air cargo seminar with the theme – 'Perspectives on Facilitating Global Air Cargo Movement' on 16 February 2016 at

the Singapore Aviation Academy (SAA). Attended by local industry stakeholders, the seminar focused on regional efforts to strengthen supply chain security, as well as the global requirements pertaining to balancing of security and facilitation of air cargo and mail. SLA was represented by Mr Gerry Tan — Honorary Secretary / Chairman of Air Cargo Committee.



# Civil Aviation Authority of Singapore (CAAS)

Throughout the year, the Association kept abreast of developments in the air cargo segment, notably with regard to new regulations, processes and technology.

There were numerous engagements with CAAS on programmes to raise productivity, improve competitiveness,

develop aviation talents and build a stronger brand for the Singapore aviation industry. Ms Ng Soo Hwa — Executive Director attended the CAAS Aviation Community Reception with the theme, "Advancing Singapore Aviation as One" on 01 July 2016 at ITE College East. The Guest of Honour was Mrs Josephine Teo — Senior Minister of State, Prime

Minister's Office, Ministry of Foreign Affairs and Ministry of Transport.

The main highlights include sharing of CAAS' key plans, as well as presentation of the Aviation in Schools Initiative awards and SkillsFuture Study Awards to commemorate the first batch of the Air Transport Sector.

# e-freight@SG Network



The Association, as represented by Mr Gerry Tan — Honorary Secretary / Chairman of Air Cargo Committee, continued to participate in the e-freight@ Singapore Steering Committee. New incentives were introduced to encourage the use of the e-freight@Singapore solution after the adoption. These incentives also intended to establish e-freight as a part of their business processes; and to encourage companies to get their partners onboard to transact with them, ultimately raising overall adoption. Several packages from CAAS and various stakeholders including SLA were rolled out in their effort to encourage adoption as a community. The challenge remains with the measured response from shippers, as they largely relay the entire operation to freight forwarders.

After several deliberations by the committee, the e-freight@Singapore was rebranded and adopted a new name, e-freight@SG Network. e-freight@SG Network was launched at the SAAA@Singapore Annual Forum: Perspectives, Bridging Effective Connections in the Air Cargo Supply Chain on 15 September 2016 at Max Atria. Mr Gerry Tan represented SLA at the unveiling of the new emblem of the Network.



The e-freight@SG Network aimed to grow the e-freight@Singapore community of air cargo shippers, forwarders and airlines. The Network comprises air cargo shippers and forwarders who have adopted one of three qualified e-freight@Singapore solutions as well as airlines that have signed up to IATA's Multilateral e-AWB Agreement. Members of the Network can enjoy benefits offered by CAAS and participating partners up to April 2019.

# Changi Airport Group (CAG)

All through the year, the CAG worked closely with the Association to strengthen Changi



Airport's connectivity across the globe.

On 28 June 2016, CAG engaged the Association for feedback on the Changi East Zone Development and several productivity projects within the air logistics community. The dialogues also delved on increasing security standards and improvements of facilities within the Changi Airfreight Centre (CAC).

One of the pertinent topics was the feasibility of a common warehouse concept, multiple users at untenanted warehouse spaces in CAC to store cargoes for a short period of time. Such a facility could benefit and help operators that experience sudden surge in inbound cargoes manage their warehousing services.

The Association outreached to SLA members and directed those interested in such a scheme to CAG.

### Let's Talk! Cargo 2016

Mr Gerry Tan — Honorary Secretary / Chairman of Air Cargo Committee and Ms Ng Soo Hwa — Executive Director participated at the Let's Talk Cargo! 2016 on 25 February 2016. Aside from CAG, the other speakers were from EDB, IE Singapore, and companies covering consultancy, e-commence and pharmaceutical industry. The papers contained an overview of air cargo performance, outlook, trends and projections. The presentation from IE Singapore touched on the One-Belt-One-Road initiative and how it could potentially impact Singapore.

# AIR CARGO COMMITTEE

### **Annual Airport Celebration 2016**

Mr Gerry Tan — Honorary Secretary / Chairman of Air Cargo Committee represented the Association at the Annual Airport Celebration that was held on 02 March 2016 to commemorate a year of exceptional service to Changi Airport's every-day service heroes. The Coordinating Minister for Infrastructure and Minister for Transport, Mr Khaw Boon Wan graced the event.



# Changi Airline Awards

The Association was represented by Mr Gerry Tan – Honorary Secretary / Chairman of Air Cargo Committee at the annual Changi Airline Awards on 28 April 2016 at Grand Hyatt Singapore where 25 awards were presented across six categories to airlines that have contributed most significantly to the growth of the Singapore air hub in 2015.



# **PSA Monthly & Quarterly Meetings**

SLA continued to participate actively at the monthly dialogue sessions and quarterly meetings hosted by PSA together with the Immigration & Checkpoints Authority of Singapore, Singapore Customs and other trade associations namely, Container Depot Association (Singapore) and Singapore Transport Association.

Besides the regular exchange of industry feedback and suggestions aimed at enhancing efficiency of port operations, the dialogues also delved on global matters that impacted the port operations in Singapore. One of the important agenda item was the amendment to the International Convention for the Safety of Life at Sea (SOLAS) that took effect from 01 July 2016 which affected operations at PSA. Although there were a number of rejected export containers and overladen cases detected at the PSA gates during the first few weeks of implementation, the number was gradually reduced to insignificant due to PSA's constant engagements with the

community. Another pertinent topic was the handling of containers and berthing of vessels operated by the insolvent Hanjin Shipping that left many ships stranded at sea.

PSA orchestrated prompt steps to broadcast several advisories to the community on affected vessels that would berth at PSA port. For delivery, a deposit of \$5,000 per container was required, deemed necessary to facilitate cargo flow and minimise disruptions to the supply chain.

PSA would refund the deposit when the empty container was returned to the designated depot / yard. The entire operation was facilitated. As part of



PSA's work plan for Year 2016, the Pasir Panjang Terminal (PPT) Building Gate 3 for containerized cargoes commenced the first phase of operation from 28 September 2016, complementing PPT Gate 4.

The phase development would continue in 2017. Organised jointly with the Traffic Police, the Annual Safety Briefings for prime mover drivers were conducted by PSA over 8 sessions from 07 August to 04 September 2016.

# PSA Safety Launch 2016

The annual PSA Safety Launch was held on 19 January 2016. Amongst the commendations, the Most Safety Conscious Haulier Driver Awards were presented to deserving drivers who practiced safe driving. The launch was also an initiative to

inculcate safety awareness amongst drivers while recognizing and encouraging drivers to achieve good safety performance in their day-to-day operations. Together with CDAS and STA, the Association supported and co-sponsored the awards.

9 prime mover drivers who excelled in safety performance won the Most Safety Conscious Haulier Driver Awards.

# LAND TRANSPORTATION COMMITTEE

# Land Transport Authority (LTA)

On 09 September 2016, LTA conducted a briefing for SLA members on enhancements to the revised Oversized Vehicle Movement (OVM) regime.

With effect from 10 October 2016, the OVM regime implemented new width requirements for permit and auxiliary

police escort as well as a new permit condition to enhance the visibility of oversized vehicles.

In another development, LTA convened meetings with the Association on 21 October 2016 and 28 November

2016 to share on a new initiative to mandate all lorry cranes to be fitted with an Audio Warning System.

This would mitigate the risk of overheight lorry cranes from hitting overhead road structures.



# Logistics & Transportation Conference 2016

SLA supported the Logistics & Transportation Conference 2016 organised by the Container Depot Association (Singapore) on 23 and 24 August 2016 at Furama City Centre.

Graced by Mr S Iswaran – Minister for Trade and Industry (Industry), two industry-led initiatives supported by SPRING Singapore were launched during the event. The first initiative is the eCTS which aims to connect all container logistics companies through a common platform. The second initiative is the TR53:2016, a technical reference on container depot operations, which provides guidelines on the general layout, safety requirement and information exchange with back-end administration. Both initiatives purport to help ensure

smooth operations between container trucking operators and container depot operators.

Mr Stanley Lim — Chairman participated at the panel discussion that expounded on the hot topic, "What does a Smart Nation mean to the SME Business of Logistics and Transportation?"



# Singapore Manufacturing Federation (SMF)

At the invitation of SMF, Mr Steve Huang — Senior Operations Manager of Poh Tiong Choon Logistics, SLA member, represented the Association in the Working Group for the review of CP 30:1985 — Code of Practice for Safe loading on vehicles. The code serves to guide transport operators, drivers and loading staff on basic safety principles that must be followed generally and the precautions to be taken in ensuring the safe carriage of the more common types of load.

# Workplace Safety & Health Council

### WSH Council (Logistics and Transport Committee)

Represented by Mr Yap Chee Sing – Council Member, the WSH Council (Logistics and Transport) Committee took on a number of work initiatives throughout the year.

This included the launch of a notebook to promote Drivers' with Safe Driving Tips that were distributed to associations, the promulgation of the WSH Innovation Award for Logistics & Transport Sector as well as promoting and reviewing the WSH Guidelines on Workplace Housekeeping. The committee also



highlighted the rise in the number of fatalities and injuries in the logistics and transport sector involving warehousing activities.

Slips, trips and falls as well as struck by moving objects were the most common incident types in the warehouses.

### **WSH Forum**

SLA member-companies were invited to the WSH Forum — A Safe Warehouse is an Efficient Warehouse on 30 June 2016. The forum was jointly organised by the WSH Council and MOM with support of the SME Centre@SMF. The forum centred on the sharing of case studies and inspection findings on warehouse safety as well as the importance of managing traffic in warehouses and the

good practices to minimise traffic risks. Useful information such as the rack system selection criteria, common problems faced and solutions were shared with the participants. There was also sharing on the 5S approach of good housekeeping at the workplace, chemical management and GHS implementation in warehouse and the concept of Return-to-Work.

### WSH CEO Lunch-dialogue

Mr Stanley Lim — Chairman attended a CEO lunch-dialogue on WSH with Mr Sam Tan — Minister of State for Manpower on 31 October 2016. Some 15 senior officials from the logistics and transport industry were present. The series of lunch-dialogue with CEOs of various sectors aimed to better understand WSH challenges and initiatives taken by companies to improve their WSH performance.

### **TrafficSAFE**

The Ministry of Manpower (MOM) piloted a new WSH assistance program named TrafficSAFE to raise awareness, guide employers on traffic safety management and help them assess and implement practices within their workplaces. The programme consisted of onsite visits conducted by WSH professionals to engage the employers, review their onsite traffic safety management plans and guide them on physical implementation of relevant control measures. A total of eight member-companies participated in the pilot program.



# LOGISTICS SERVICES COMMITTEE

### WSH Awards

The annual WSH Awards are presented by the WSH Council and supported by the Ministry of Manpower. The awards recognize organizations and individuals who have contributed to achieving excellence in workplace safety and health. In 2016, a new category – WSH Innovation Awards 2016 for Logistics and Transport Sector was created.

The award aims to recognise work teams in the Logistics and Transport sector

which have initiated innovative practices or solutions that improve safety and health in the workplace.

The Association championed and coordinated the inaugural WSH Innovation Award for Logistics & Transport Sector 2016 and drive participation amongst logistics companies. An introductory briefing of the WSH Innovation Awards 2016 for the Logistics and Transport Sector took place on

01 February 2016. Conducted by WSH
Council, the briefing was well attended
by organistions in the sector. A total of 6
finalists made spirited presentations on 13
May 2016 to a judging panel comprising
Mr Thomas Teo – Senior Assistant
Director, OSH Inspectorate Department of
MOM, Mr Perry Hung – Manager, Industry

# **Business Continuity Management (BCM)**

A collaborative effort between SLA and the Singapore Business Federation (SBF), the BCM - Readiness Framework handbook for companies in the cold chain, warehousing and storage industry was introduced at the BCM Annual Conference on 06 January 2016. The standards enable businesses to understand and prioritise

the threats to their businesses, as well as put in place a management system to protect against, reduce the likelihood of, and ensure that the business recovers from disruptive incidents.

As the BCM focal point, SBF invited SLA member-companies to an Info-Session

on Verifiable Business Continuity Plan (BCP) Initiative, "Plan to be Future-Ready, Today!" on 26 April 2016. The Verifiable BCP Initiative enables Singapore companies to tap on SPRING Singapore's Capability Development Grant to develop their BCPs and contingency measures to address specific and recurring scenarios.

# Centre of Innovation – Supply Chain Management

At the invitation of the Centre of Innovation — Supply Chain Management (COI-SCM), close to 20 representatives from 10 member-companies attended a session on 26 April 2016 at Republic Polytechnic to gain an appreciation on Container Transport Performance Measurement. Using real historical data of a member-company, Mr Dennis Quek — Director, COI-SCM shared the insights from the analysis, and how those findings can translate to productivity improvement opportunities for companies and the industry.



# SPRING - Logistics Associations Meetings

SPRING Singapore actively engaged the Association to examine the common problems and pain points in the haulage industry.

On 02 February 2016 and 11 March 2016, SPRING Singapore coordinated the SPRING-Logistics Associations meetings together with SLA, CDAS, SAAA@ Singapore and STA to align all efforts in developing the industry. The meetings facilitated discussions surrounding the next generation platform and its potential applications. One of the proposed initiatives included the U-Drive solutions, a B2B transport job sharing platform.



# **Industry Transformation Map for Logistics Industry**

The ITM for Logistics was launched on 16 November 2016 by Mr S Iswaran -Minister for Trade and Industry (Industry) at the Ground Breaking of the JTC Logistics Hub @ Gul event. The road map for logistics aims at reinforcing Singapore's position as a global logistics hub. It is set to add \$8.3 billion in value to the sector and create 2,000 jobs for professionals, managers, executives and technicians (PMETs) by the end of the decade. ITM will support enterprise-level efforts to transform and grow through productivity and innovation. It aims to nurture a strong Singaporean core through talent development and in turn

will help companies, in particular, the SMEs to scale up and internationalise.

The message was echoed by Mr Kay Kong Swan — 1st Deputy Chairman / Chairman — Logistics Services Committee during the interview by Channel News Asia at the event.

In conjunction with the ITM launch, the Logistics Industry Career Guide was showcased. Mr Thomas Sim – 2nd Deputy Chairman / Chairman – Training & Development walked the Minister through the eGuide which featured 9 logistics professionals and the career

opportunities in logistics.

The property would be Singapore's first high-rise, multi-tenanted facility to house Inland Container Depots, warehouses and heavy vehicle park within a single development. Mr Kay Kong Swan represented SLA at the symbolic Ground Breaking Ceremony.

The Innovation & Collaborative Technology (ICT) Committee is refreshed from the former e-Logistics / Technology Committee with the following revised Terms of Reference:

Creating synergy with industry partners and raising awareness on smart innovation and digital technology so as to benefit the members.

The renaming and re-scoping of the committee is in response to the changing trend of the logistics industry with proliferating adoption of new technologies and e-commerce activities. A redefinition in the scope of the ICT Committee is also in line with the Industry Transformation Map to drive innovation and adopt automation / technology to boost productivity.

Throughout the year, the Association engaged closely with government agencies and solutions providers to acquaint with packages made available to companies in the logistics sector.



With emerging technologies, the Association would constantly assess the operational processes and requirements of members. Through collaborative events with other trade associations and business associations, SLA members were kept abreast with new industry updates.



# Internet of Things (IoT) Asia 2016

Jointly organised by the Singapore Industrial Automation Association (SIAA) and SingEx Exhibitions, IoT Asia was held from 30 to 31 March 2016 at Singapore EXPO, with SLA as one of the supporting organizations. Themed "Losing the Gap: from Vision to Reality", the event was graced by Dr Vivian Balakrishnan, Singapore's Minister for Foreign Affairs and Minister-in-Charge of Smart Nation Initiative. The event revealed new insights on emerging trends, new key technologies and directions for IoT's proliferation in the region. It also stimulated in-depth discussions to drive business collaborations in the region and undertake the real nuts and bolts of IoT implementation to make it a reality.

TR46 is the culmination of efforts by key industry representatives in the Last Mile Delivery Working Group of the Technical Committee for Logistics, which comes under the purview of the Manufacturing Standards Committee managed by SMF-SDO. SLA is represented by Mr Teo Woon Hun — SLA Deputy Honorary Secretary. The ICT Committee convened a meeting with Info-communications Media Development



Authority of Singapore (IMDA) and SPRING Singapore on 26 October 2016 to delve on the TR46:2016.

As part of a continuous project, IMDA aimed to upgrade it to the Singapore Standards and be the benchmark and

reference for the region. A Working Group was formed to look at training, development of a platform for ecommerce LSPs using TR 46 and an accreditation program to recognise LSPs complying with TR46. SLA is represented by Mr Chan Hsien Hung – ICT Committee Member in the working group.

# Wong Fong Industries Limited

At the invitation of Wong Fong Industries Limited, SLA organised a site visit for members on 25 August 2016. The company is the leading providers of land transport engineering solutions. The Wong Fong Research and Innovation Centre (WFRIC) was established in 2013 to research on the future of the transportation industries.

The evening saw the coming together of over 50 SLA members and industry practitioners to network and expand their business contacts. The members had the opportunities to view their range of electric vehicles and fast charging batteries.

# Simplifying Logistics through Technology Adoption

SLA together with A\*STAR coorganised the half-day presentation on Simplifying Logistics through Technology Adoption on 28 October 2016, with support from the Workforce Singapore.

A group of 67 representatives from 22 member-companies and organisations from various sectors were introduced to several affordable plug-and-play technology solutions that companies could adopt to improve productivity. Besides the sharing from A\*STAR's manufacturing arm, Singapore Institute of Manufacturing Technology (SIMTech) on Collection, Delivery & Management System, wfMOBILE™ and Vehicle Routing Optimisation, the line-up include VersaFleet on logistics trends of disruption and digitisation as well as Enhanzom on FITPRISE Enterprise Management System. The participants



also toured the mini booth exhibition showcasing the solutions during the networking session.

# Regional SLA Trade Facilitation Platform

With support from IE Singapore, SLA was making plans to submit a proposal under the Local Enterprise and Association Development (LEAD) Programme at the end of the year to develop a regional trade facilitation platform. Working together with GeTS Asia, a member, the new portal would be a global B2B commerce platform.

It would leverage on innovative use of technology to drive cross border trade, innovation and value creation within the logistics and supply chain industry. Discussions were intensified following the signing of a Memorandum of Understanding between the Association and GeTS Asia on 22 September 2016.


The proposed new SLA portal would allow members and companies to tap on the global connectivity to gain access to the global markets and seek new growth opportunities. The preliminary plan is to build connectivity in phases, first within ASEAN, then to ASEAN  $\pm$  6, and eventually to Asia Pacific, United States, Europe, Middle East/Africa and Latin America.

SLA and GeTS Asia are in close liaison with several ASEAN Federation of Forwarders Associations (AFFA) members. One of them, the Thai International Freight Forwarders Association successfully piloted a trial link with a Singapore logistics company.

The SSG Category B enhanced funding scheme for the Specialist Training Programmes was successfully renewed from 01 April 2016 to 31 March 2018. Company-sponsored participants can continue to benefit from the support to upgrade themselves.

# SkillsFuture Singapore (SSG)


### Skills Framework for logistics
